RULES AND REGULATIONS

- 1. By taking part in the MTCC, you undertake to obey the rules as set out herein and in paragraph 2 below ("the Rules").
- 2. 2. The following Rules apply to all events in the MTCC 2019 and you shall comply with them:
 - (i) The competition rules of the International Tree Climbing Championships (English version, revised June 11 2014) by the International Society of Arboriculture. The complete sets of Rules are available at:- http://www.itcc-isa.com/resources/rules-2014RuleBook Final.pdf, you will be deemed to have read and familiarized yourself with the Rules;
 - (ii) To be an eligible participant for Malaysia Tree Climbing Championships, you must be:
 - (a) A member of any tree climbing association or; International Society of Arboriculture Society (ISA) and;
 - (b) Must have successfully completed Basic Tree Climbing Course or equivalent or have competed previously in a MTCC, STCC or APTCC or any tree climbing competition.
 - (c) Eligible competitors must complete and submit the official 'Climber Entry and Waiver Form' to Persatuan Arborist Malaysia (PArM) on or prior to the closing date as specified by the MTCC 2019 official organizer.
 - (d) Eligible competitors must make full registration payment to PERSATUAN ARBORIT MALAYSIA prior to the competition date as specified by the MTCC 2019 official organizer.
- 3. The Persatuan Arborist Malaysia (the "Organiser") reserve the right to amend the Rules at any time, or to implement any other rules or instructions for the general safety of all participants.
- 4. You understand and accept that participation in the MTCC 2019 may involve certain risks and dangers that may result in serious injury, paralysis, disability or death and you hereby freely and voluntarily assume all risks and undertake responsibility for your own health and safety during the MTCC 2019.
- 5. You understand and agree that the Organiser and their employees or agents shall not be liable to you or anyone entitled to claim through you for any injury (including death, paralysis or disability) or damage or loss of your property sustained by you, in connection with or in the course of your participation in the MTCC 2019, and you hereby waive all your rights against the Organizers.
